Therefore, after each module there is a Working Example for the students to apply the methods they learned in class. Ultimately, the flow of the workbook is as follows: 1) the student plays the role of a patent practitioner who has a consultation with an inventor to formulate an invention disclosure, 2) Drafts a patent application based on the invention disclosure and submits (hypothetically) to the USPTO, 3) Utilizes a given set of prior art against the application as an examiner would to formulate 102 and 103 rejections and sends (hypothetically) the Office Action back to the patent practitioner, and 4) Finally the students apply their knowledge base by drafting and sending (hypothetically) an Office Action Response back to the USPTO.
